

Thomas Becket Catholic School Northampton Admissions Policy for 2021

1. Introduction

- 1.1 Thomas Becket Catholic School is a part of the Our Lady Immaculate Catholic Academy Trust (OLICAT). It is situated in the town of Northampton within the Diocese of Northampton and is an Academy. The School exists to serve the Catholic Communities in Northampton.
- 1.2. The Trust Board is responsible for determining and administering the policy relating to the admissions of pupils to the four schools. It is guided in that responsibility by the requirements of the law, by the advice of the Diocesan Trustees and in its duty to the school and the Catholic community.
- 1.3. The Trust Board has delegated responsibility for determining admissions to the Admissions Panel of the School Committee.
- 1.4. The School Committee has set the published admissions number for Thomas Becket Catholic School as 180 pupils for the school year commencing in September 2021. In addition there are 20 places per year for external Year 12 and 13 students for admission into the sixth form.
- 1.5 No charge of any kind will be made by the school in connection with any application.

2. Mission Statement.

'Christ's Love is Our Foundation'

Thomas Becket Catholic School prides itself on being a Catholic, listening and learning school. The students are at the heart of everything we do and we challenge our staff to: Love the children and let them know that they are loved.

As a Catholic school, we aim to provide a Catholic education for all our pupils. At a Catholic school, Catholic doctrine and practice permeate every aspect of the school's activity. It is essential that the Catholic character of the school's education be fully supported by all families in the school. We therefore hope that all parents will give their full, unreserved and positive support for the aims and ethos of the school. This does not affect the right of an applicant who is not Catholic to apply for and be admitted to a place at the school in accordance with the admission arrangements.

3. Procedure

Parents and guardians wishing to apply for a place in the school for their child MUST complete the Local Authority Preference Form. This can be done either online, available by visiting the admissions website at www.northamptonshire.gov.uk/admissions may be submitted directly to the Local Authority. Applications must arrive by 17th January 2020 by 5.00pm.

Applicants wishing to be considered under the school's faith and sibling criteria should also complete the Supplementary Information Form Admission form / certificate of catholic practice with the relevant section completed by their Parish clergy, Minister or Faith Leader and return it to the school by 5.00 pm on the 17th January 2020. Although these forms are not mandatory if one is not received the Governors may not be able to fairly apply their admission criteria. In this circumstance the application will be considered under admission criterion No.4.10. "Any other children".

Note the submission of the form does not reserve a place at the school.

Pupils who are admitted to the school will enter the Year 7 class during September of that year and will attend on a full time basis. Once all applications have been received by NCC, a list of children who have applied for a place will be provided to the school with details from their NCC applications forms.

All on time applications will be considered at the same time, after the closing date for Admissions.

The Admissions Committee will consider all applications according to the criteria set out below and without reference to the ability or aptitude of the child.

4. Criteria for Admission

Children with statements of Special Needs or an Education, Health and Care plan in which the school is named will be admitted according to the regulations and the policy of the Local Authority.

It is presumed that any parent/guardian applying for a school place is sympathetic to the Catholic ethos of the school.

The Governors will give priority to Catholic children. If there are more applications than places available, priority will be given as follows:-

- 4.1. "Looked after Children" or previously "Looked after Children" who are baptised in the Catholic Faith
- 4.2. Baptised Catholic children who have a brother or sister in the school at the time of admission.

- 4.3. Baptised Catholic children whose family are practising Catholics and whose application is supported by the Clergy of their parish.
- 4.4 Other Catholic children
- 4.5. Other "Looked after Children" or previously "Looked after Children"
- 4.6. All other children who have a brother or sister in the school at the time of admission
- 4.7. Children of families of other Christian denominations whose application is accompanied by a statement that the applicant is "a known and practising member of the congregation" and is supported by their Minister of religion.
- 4.8. Children who currently attend Our Lady Immaculate Catholic Academy Trust (OLICAT)
 Primary schools at time of admission.
- 4.9. Children of staff.
- 4.10. All other children whose parents or guardians wish their child to receive a Christian education.

5. Oversubscription

- 5.1. If the admission number is exceeded within any of these criteria priority will be given to those who live nearest to the school. Distances are measured from their home address to the nearest access gate to the school grounds. Measurements are made on a straight line basis, using a geographical information system in accord with the Local Authority's admission procedures. The Local Authority's computerised measuring system will be used in these cases.
- 5.2 In the event that the distance criteria results in two or more applicants being equally distant from the school the final space will be allocated in accordance with Local Authority Practice.

THE ABOVE CRITERIA WILL BE APPLIED TO THE ADMISSION OF CHILDREN OF ALL AGES INTO THE SCHOOL. IF YOUR CHILD IS REFUSED ADMISSION, YOU HAVE A RIGHT TO APPEAL AGAINST THAT DECISION.

6. Waiting list

- 6.1. The Admissions Committee will keep a 'waiting list' of those children who have not been offered a place. The list will be ranked according to the admissions criteria.
- 6.2. Waiting lists are cleared at the end of July each year. Parents and Carers must contact the school in writing at the beginning of July if they wish to renew their child's name on the list.

7. "In Year" admissions

- 7.1. Applications for "in year" places during the school year are administered by the Local Authority. Parents and guardians wishing to apply for a place in the school for their child MUST complete the Local Authority Preference Form. This can be done either on line, available by visiting the admissions website at www.northamptonshire.gov.uk/admissions or, alternatively, a paper Preference

 Form (available from the Local Authority) may be submitted directly to the Local Authority. Applicants wishing to be considered under the school's faith and sibling criteria should also complete the Supplementary Information Form and a Reference Form from their Parish Clergy or Religious Leader.
- 7.2. Applicants wishing to be considered for "in year" admission under the school's faith and sibling criteria should also complete the Supplementary Information form and return it to the school at the same time as the form is sent to the Local Authority. A failure to do so will mean that the application cannot be considered under those criteria.
- 7.3 Applicants for "In Year" admission will be considered equally with those on the waiting list.
- 7.4 Pupils admitted under The Fair Access Protocol have priority over other students to be admitted including any on a waiting list at that time.

8. Appeal Details

Parents have the right to appeal against the Governors' refusal to admit their child/children. To appeal against the decision the parents should write to the Clerk to the Governors. If your child is refused admission, you are invited to appeal in writing to the Chair of Governors at the school. Appeals will be heard by an Independent Panel.

9. Additional Information

- 9.1. The parents of those children whom the Admissions Committee have agreed to admit as pupils at the school will be informed on the national allocation day.
- 9.2. The parents of those children whose application for a place was unsuccessful will be offered a place at an alternative school by the Local Authority. The allocation of places is made by the Local Authority according to the school's Admission criteria.

10. Admission to the sixth form

- 10.1 Pupils currently studying at Thomas Becket Catholic School are entitled to a place in our Sixth Form subject to achieving the relevant GCSE grades for the course(s) to be studied.
- 10.2 The planned admission number for students outside Thomas Becket Catholic School year 11 from other schools is 20 students.
- 10.3 External applicants must fulfil the same course requirements as internal applicants.
- 10.4 If there is an excess of applications over the available places priority will be given on the basis of the criteria for admission in section 4
- 10.5 Specific Entry Requirements

Level Three Course Minimum of 5 GCSEs at grade C or above
Specific grades according to course applied for – e.g. Science, Maths, English Literature

Level Two Course: Minimum of 4 GCSEs at grade 3 or above

Level One Course: Any Student who has not achieved Level 1 at the end of Year 11 will be encouraged to continue in an appropriate learning environment and on a suitable course.

11. Definitions

Brother or sister means a brother or sister sharing the same parents, or a half-brother or half-sister where two children share one common parent, or a step-brother or step-sister, where two children are related by a parent's marriage/partnership, including adopted or fostered children. A brother or sister must be living at the same address when the application is made.

Baptised Catholic means children who have been baptised as Catholics, or have been formally received into the Catholic Church. All applicants seeking admission under this criteria will be asked to provide evidence that the child has been baptised as a Catholic or has been received into the Catholic Church. A baptismal certificate or a letter from their Parish Clergy confirming priest confirming their baptism or Year 7 into the Catholic Church will be required.

Children of Staff will be admitted where either the member of staff has been employed at the school for two or more years when the application is made, or the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.

Christian means a member of a church which is part of Churches Together in England. A list of these Churches is available from the school office.

Families means parents, step parents and grandparents.

Home address means the permanent residence of the child when the place is offered. Where a child lives between two parents the qualifying address is where the child sleeps the majority of the school week.

Known and Practising Member of the Congregation means the family of the child is regarded by the priest/minister/worship leader as part of the worshipping community of the church/worship centre. This would not necessarily mean that the parent is a 'Member' in a technical sense (e.g. through baptism, confirmation or electoral roll) but would imply a pattern of attendance at worship (on Sunday or at other times) that is more than 'occasional' and has been sustained for more than a six months in the year prior to the date of signature.

Looked after Children Children who are in the care of a local authority or provided with accommodation by a local authority and all previously looked after children, including those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted. (see the definition in Section 22(1) of the Children Act 1989).

Children of Other Christian Denominations means children who belong to other churches and ecclesial communities which, acknowledge God's revelation in Christ, confess the Lord Jesus Christ as God and Saviour according to the Scriptures, and, in obedience to God's will and in the power of the Holy Spirit commit themselves: to seek a deepening of their communion with Christ and with one another in the Church, which is his body; and to fulfil their mission to proclaim the Gospel by common witness and service in the world to the glory of the one God, Father, Son and Holy Spirit. An ecclesial community which on principle has no credal statements in its tradition, is included if it manifests faith in Christ as witnessed to in the Scriptures and is committed to working in the spirit of the above.

All members of Churches Together in England and CYTÛN are deemed to be included in the above definition, as are all other churches and ecclesial communities that are in membership of any local Churches Together Group (by whatever title) on the above basis.

Previously Looked after Children means children who were in the care of a local authority, but who ceased to be so because they were adopted, or became subject to a residence order or special guardianship order.

Practising Catholic means that one parent or grandparent attends Mass on days of obligation, unless excused for a serious reason (for example, illness, the care of infants) or dispensed by their own pastor. Evidence of this commitment must be provided by their Parish Clergy where the family normally worship through a certificate of catholic practice.
